BVIC Receives \$150,000 Grant

The California Department of Rehabilitation (DOR) Older Individuals Who Are Blind (OIB) program has provided us with a \$150,000 grant to be used for strategic initiatives, to build infrastructure, for staff professional development and to purchase supplies used with OIB eligible clients. Currently 89% of our clients are OIB eligible.

Over the course of 2016 we will use these funds to:

- upgrade all staff computers and network them to a file server
- purchase a case management software program for e-tracking of client information
- hire a strategic planning consultant to lead us in creating a new course
- hire a fund development consultant to help us create a strategic constituent and fund development plan
- purchase a constituent/donor database program
- provide all staff a variety of professional development opportunities

- hire a marketing firm to help us create a strategic outreach/marketing plan, along with new collateral materials
- and purchases a wide variety of assistive devices and tools

The total estimated costs for all these activities is \$200,000, with DOR covering \$150,000 of it. Vision Loss

Marjorie R. McNeely Low Vision Clinic

Age-related macular degeneration (AMD) is a progressive eye condition affecting as many as 15 million Americans, with 200,000 new cases each year. AMD reduces our sharpest central vision and gets in the way of reading, driving, identifying faces, watching television, safely navigating stairs and performing other daily tasks. AMD never causes light-out blindness, but it could leave dim images or holes at the center of vision. There are two types of AMD – wet and dry. Dry macular degeneration is the more common of the two and is also the one with the fewest options for treatment. Wet AMD treatment options are more readily available. It's important to know dry AMD symptoms and wet AMD symptoms and what you can do about them.

If your family member, friend or yourself is diagnosed with AMD, there is help and hope. Please contact us at the Marjorie McNeely Low Vision Clinic (649-3505). Our specialists will help you understand your visual condition and recommend helpful devices to compensate lost visual function. Among the 204 individuals whom we served in the clinic in 2015, 134 (66%) have been diagnosed with AMD.

We also recommend signing-up for monthly email updates and newsletters with Macular Degeneration Partnership. Their website is www.amd.org. You will have access to the vast information regarding treatment advancement.

Donated low vision aids are now available. If you have been evaluated at our low vision clinic and found new devices unaffordable, you may be eligible for donated low vision aids depending on their availabilities. Please contact us at 649-3505.

Bequests are an easy way to plan for support after you are gone by simply arranging for a transfer of assets to BVIC through your will or trust. Bequests can occur in several forms such as:

- Specific bequest a specified amount of cash, securities, or property
 - "I bequeath \$___ [dollar amount or description of property] to The Blind & Visually Impaired Center of Monterey County, Inc. located at

225 Laurel Ave, Pacific Grove, CA 93950. Federal Tax ID#: 23-7221588."

- Percentage bequest a stated percentage of the donor's total estate
 - "I bequeath ___% [% of total assets] to The Blind & Visually Impaired Center of Monterey County, Inc. located at 225 Laurel Ave, Pacific Grove, CA 93950. Federal Tax ID#: 23-7221588."
- Residual bequest all or a portion of what remains of the estate after specific and general bequests are distributed
 - "I bequeath [dollar amount or % of remainder of property] to The Blind & Visually Impaired Center of Monterey County, Inc. located at 225 Laurel Ave, Pacific Grove, CA 93950. Federal Tax ID#: 23-7221588."
- Contingent bequest a gift that takes effect only if the primary beneficiary or beneficiaries predecease you
 - "If neither my spouse nor any named beneficiaries survives me, then I give, bequeath and devise all the rest, residue, and remainder of the property, both real and personal, which I may own or be entitled to at my death, to The Blind & Visually Impaired Center of Monterey County, Inc. located at 225 Laurel Ave, Pacific Grove, CA 93950. Federal Tax ID#: 23-7221588."

You may specify the use of your bequest to support a particular program, such as the low-vision clinic, for general support or designate it to the endowment to ensure ongoing support for the life of the Center.
